WHY WE DO THIS

The world's housing need is vast: 1.6 billion people live in poverty housing. That's one in every four people on this planet. Every day we meet families haunted by the fear of eviction, storms, floods and disease. Their children are cold and ill, often unable to go to school. It becomes a vicious circle and they struggle to make a living. We just want to reach out and give families safe, healthy, dry homes where they can feel secure and thrive.

WE DO THIS BY....

- providing housing micro finance to enable families to renovate and improve their homes.
- funding specific housing-related projects.
- using our building expertise to provide disaster relief and reconstruction.
- delivering construction and finance training to help people with their own projects.

Every 5½ minutes a family builds or improves their home with Habitat for Humanity.

We have just reached huge milestones:

- Over 3 million people served since 1976.
- Over 800,000 homes built, repaired and renovated since 1976.

CHAIRMAN'S STATEMENT — looking back on 2012-13

A long career in house building has given me a deep appreciation of the importance of having a decent home and the bearing it can have on an individual's life.

My roles with various house builders (and as Executive Chairman of the Home Builders Federation) have given me an insight into the vital role the home plays for families here in Britain; whilst my role as Chairman of Habitat for Humanity Great Britain has given me a wider international perspective.

I fundamentally believe that delivering a proper home has a life-changing influence on families in desperate need. Helping deliver this basic human requirement is deeply fulfilling work and is a goal all of us with the opportunity to do so should strive ever harder to achieve. A proper, safe home is not a luxury. It is one of life's essentials and should be available to everyone.

That is why I am so proud of the imaginative solutions Habitat for Humanity provides for people, both here in Britain and overseas. Habitat for Humanity works where it matters most, at the heart of local communities all over the world in the most desperate housing need. We help people in their darkest hour and have the expertise to help them turn their lives around.

I am honoured to have served this second year as Chair. But these are challenging times. Habitat for Humanity GB is undergoing a period of consolidation and change. After 17 years of dedication to the movement, including the past decade at the helm of the GB organisation, Ian

Walkden decided to move on to pastures new. His contribution has been immense and my fellow board members and the global team wish to thank him for his tireless contribution to the mission.

We were fortunate that Ian Pearce was able to step up to the position of Interim National Director and indeed delighted that he has taken on the newly-created position of Chief Operating Officer.

We were then delighted to appoint Rebecca Martin as our new National Director. Rebecca has been an unwavering supporter of Habitat for Humanity for 10 years, recently assisting with fundraising and marketing on a voluntary basis.

She comes with considerable experience as a successful publisher, sales and marketing director, commercial director and events producer. She has worked across a number of industries most notably in the legal sector and as Publisher of *PublicPrivateFinance*, with a portfolio of conferences and awards serving the Project Finance Markets. In 2002 Rebecca set up Blueamber Group Ltd, a successful Events and Communications Company which ran events to bring together stakeholders responsible for public infrastructure in the UK. She closed Blueamber in 2007 when she had her first child. Rebecca is ideally placed to develop our fundraising potential, supported by a new senior leadership team.

She joins us at an exceptionally challenging period. The ongoing harsh economic climate demands that we strive ever harder

to improve how we operate to achieve our goals. So, to ensure we are in the best possible shape to deliver our objectives and to develop a much sharper fundraising edge, we are restructuring the organisation. Rebecca's previous business experience will help us in this process.

Our income for the period was £2.7 million, 98% of which was from grants and donations, with an increase in corporate giving of 8%. This was a 17% decrease for this period, a result of the difficult economic climate.

Our support for Habitat for Humanity projects around the world totalled £1.2 million. As well as the work we do in the UK, we are supporting projects in over 20 countries including Bangladesh, Bolivia, Brazil, Cambodia, Egypt, Haiti, Lebanon, Madagascar, Mozambique, the Philippines, and Vietnam.

We work in a variety of ways: house repair and construction; disaster response and reconstruction; advocacy programmes; land tenure; and accessibility to affordable housing finance. Our home programme to build and renovate Britain's empty homes is expanding as a result of the housing crisis here in the UK.

Our Hope Builders fundraising initiative has provided the most significant input into unrestricted fundraising, with the homebuilding industry increasingly making us the charity of choice. Our particular thanks go to Mike Freshney, who has spearheaded this very successful campaign.

The Habitat for Humanity GB team has



worked extremely hard to nurture our donor relationships, manage volunteering, restructure our domestic programme, develop fundraising events and attend to the many risks associated with this sector. The Deputy Chair, Susan Revell and I, together with the rest of the Board, are deeply appreciative of all their hard work. I would also like to thank the Board and our Patrons for their continued loyalty and support.

As we enter 2014, I feel confident that as an organisation we are becoming increasingly focussed on how we will reach our objectives.

I hope you will take the time to look through this review and that it gives you an understanding of how our funds have been allocated and an insight into the exciting work being carried out by Habitat for Humanity all over the world.

NATIONAL DIRECTOR'S STATEMENT — looking forward 2013-14

Every child deserves the right to a proper home. When I put my children to bed at night, I know we are lucky to have a home that we love but I also know that with such privilege comes huge responsibility. I believe we have a duty to those who are unable to protect their children from the poverty they were born into and our mission is simple. At Habitat for Humanity we want to ensure

that everyone has a decent place to rest their heads at night, no matter where they are in the world.

I want people in the UK to know about us and how our global goal is to help as many people as possible to find safe homes so that they no longer have to live on the very edge of existence. As I write, more than one billion people around the world are living in slum conditions or homes totally unfit for human habitation. Since 1976, Habitat for Humanity has helped over 100,000 families and built and renovated 800,000 homes worldwide. But there is so much more we can do.

Many people are still unaware of the work we do at Habitat for Humanity and I want to change that. I want everyone to know that following major disasters we can bring decades of expertise and experience to help build solid structures which can resist the most extreme of weather. Even now, every pound we raised to help our response in the Philippines is being used to provide houses that protect some of the most vulnerable communities in the world from future natural disasters. Here, in the UK, we are proud of our work and a volunteer programme which encourages the rebuilding of empty houses. What's more, because we work with corporate and local partnerships wherever we are, we can pool resources so that more and more families can go to bed at night in a safe, secure home.

My great thanks must go to our UK supporters whose generosity has been

extraordinary throughout these difficult economic times, and also to our volunteers whose dedication always exceeds what we ask of them. We could not do it without you.

I am totally committed to making Habitat for Humanity a top 100 UK charity. My experience in the commercial sector, in building partnerships with those who can help and in making sure the money goes where it needs to, puts me in a strong position to deliver this goal. Our mission is to help make poverty a thing of the past through bringing safe sustainable housing to those who need it. I want to see the UK team play a major part in delivering that mission.

POWER IN NUMBERS

The Women of District 9, Cochabamba, Bolivia, have been living in fear of eviction, at the mercy of unscrupulous landlords. On 5th June 2012 that all changed. Habitat for Humanity has enabled these mothers to change the law so that they have the legal right to own property. We will continue to support them to buy their land rights and build and improve their homes.





SUBSIDISED HOUSING FOR VULNERABLE PEOPLE

Those living in the most poverty are often the least able to help themselves into a better future. This may be because they suffer from leprosy in Ethiopia, are disabled in Egypt or are living with HIV in Cambodia. Although their accommodation is amongst the most appalling on earth, they will still be paying rent.

What we have found in Cambodia, for

example, is that by providing a free housing asset, together with training in developing aspirations and earning a small living, a tremendous difference can be made. For a start, there is more disposable money just by not having to pay rent. Our research showed that families were using this for school fees and better nutrition. An entire family can be turned around, for generations to come.

joy at having a new, safe home following the Khmer Harvest Build, Cambodia, 2011. Before working with Habitat for Humanity, she lived in a shack made of scrap metal in a slum in Phnom Penh. They survived by scavenging from the dump next door. Now they have a proper home with a toilet and solar panels which power a fan, overhead lights and a radio.

PROGRAMME OVERVIEW

DISASTER RESPONSE

During the course of the year, we supported six disaster responses: two in the Philippines; and one in Haiti, Nepal, Vietnam and Bangladesh.

Most responses focussed on emergency shelter kits which provide sufficient material for people to put a temporary shelter over their heads — most critical straight after the disaster. This is just the first step as people begin the process of improving their shelter, salvaging materials and buying supplies when they begin to earn again. In some situations, once the disaster is over, we are able to offer small loans to speed up the process so that people end up in more permanent homes that are less prone to disasters.

PROGRAMME OVERVIEW

LAND TENURE AND PROPERTY RIGHTS

Many people are living in squalor, especially in slums, because without secure land tenure they are unable to improve their homes. There is little point in investing in a property one day if it may be bull-dozed the next. Our focus in Brazil and Bolivia is on helping local people, especially women, gain land rights. We do this through a mixture of training the women to advocate for and claim their rights, by working with the local authorities to remove the blockages in their systems, and by providing people with legal access to register their rights.

And the rest is down to them. With land title they have every motivation in the world to improve their lot.

HEALTHY HOMES — WATER AND SANITATION

When we think of a home we also think of water, sanitation and cooking facilities. The lack of such facilities is the frequent cause of water-borne and respiratory disease. However, the provision of these facilities for people who have never had them before is not enough to ensure good health. They also need training in best hygiene and food preparation. And then this needs to be monitored to ensure that the practices become embedded. People may well take out a home improvement loan for a toilet for example, but when we build subsidised homes we will include these facilities together with training in their usage. Water and sanitation is a major focus of our work in Bangladesh for example.



10-year old Sherling is over-come at the dedication of her family's new Habitat for Humanity home. Before this, they were living in one room with three walls and a tarpaulin roof. Her letter of thanks to the volunteers concluded 'when you leave, there will be an empty space in my heart.'

HOME OWNERSHIP IS EMPOWERING

Felicia lives with five of her children in a house with one bedroom in Cochabamba, Bolivia. Her husband died 15 years ago. She is attending Habitat for Humanity's advanced women leaders' school where she is learning to advocate, map land, and secure land rights and a future free from the fear of losing homes.



AFFORDABLE HOUSING **FINANCE**

Lack of access to housing finance is another reason for people living in appalling conditions. Our approach is to work with carefully selected micro finance organisations and help them to develop home improvement loan products. After all, they know who has a good track record of repayments. We train these organisations in home improvement loans and provide them with capital to make loans to people living in housing poverty. In some cases we also provide technical support to people who take out loans to help them in their quest to make their loan stretch.

THE KING'S GROVE PROJECT, PECKHAM, LONDON

The latest of our projects here in Great Britain community volunteers and partner charities is in Peckham and used to be a large derelict empty Victorian terraced house. It is now two beautiful flats - much needed homes for two women-led families in need of secure housing. Working in partnership with Housing for Women, these families will now be able to rebuild their lives during the ten year period afforded by the lease.

We were privileged to have Stephen Williams MP to officially open this much-needed renovation. He attended as Parliamentary **Under-Secretary of State for Communities** and Local Government, along with 70 guests: government officials; corporate supporters;

– all with a connection to the project. He mentioned the project shortly afterwards in the House of Commons stating:

'We genuinely want innovative models of delivery for housing provision on the ground, where we can work with social enterprises and charities and bring people together to achieve real regeneration in their area. A couple of weeks ago, as the Minister responsible for the empty homes programme, I handed over the keys to a house in Peckham. The number of people involved in that project was quite *staggering: with not only the formal delivery* partners – the Government, Southwark

Council and the two housing associations but also 300 volunteers. Some had painted a bedroom; others had done the carpeting, and so on. The Government is genuinely open to innovative solutions that involve as many people as possible in shaping their own communities, and I certainly think that the co-operative model for providing new housing is something that ought to be explored a little bit further.

We are so grateful to all our supporters and the 400 volunteers who worked so hard to make this sizable community project happen in just eight months.

PROGRAMME OVERVIEW

EMPTY HOMES

Along with the construction of newbuild homes, Habitat for Humanity is committed to a programme renovating empty and disused properties, for use by families with housing needs. Working closely with private homeowners, landlords and local authority empty homes officers, we are leasing properties for between five and ten years to provide safe, decent and affordable housing for local families in

I was really impressed with everything down to our transport to and from the site, our daily objectives, the accommodation, the entertainment and the support mechanisms in place. Personally this was a life changing experience.


